## **TERMS AND CONDITIONS OF SALE**

### **ACCEPTANCE**

Accurate Lock and Hardware Co., LLC reserves the right to decline an order, in whole or in part, when the type or quantity of goods or credit worthiness of the Purchaser is not satisfactory to us in our sole and absolute discretion.

Purchase Orders, Quote Requests, Acknowledgements or the like issued by the Purchaser that have contrary standard terms and conditions are not binding on Accurate Lock and Hardware Co., LLC.

Orders will be confirmed upon receipt of all necessary information and will be processed as shown on the order confirmation unless any changes or revisions are acknowledged prior to start of production.

At the request of the customer or for clarification purposes, Accurate Lock and Hardware Co. may produce drawings for approval. Accurate Lock retains all rights, including the exclusive right of use. Possession of such drawings by the customer does not convey to the customer any rights.

### **PRICES**

All prices are subject to change without notice and are not guaranteed. All shipments will be made at prices in effect at the time of shipment. We reserve the right to correct clerical, stenographic and other obvious errors at any time.

If Accurate Lock and Hardware Co., LLC elects to offer a quote, such quote will be valid until the expiration date on that quote or as agreed with one of Accurate Lock and Hardware Co., LLC 's authorized representatives. A quote number must be provided at the time of ordering. A quote may be null and void if the Purchase Order does not include ALL product lines listed on the quote or if the quantities for any item covered by the quote deviate by 10% or more. Any new order requesting special pricing to match an existing quote number must be approved by Accurate Lock and Hardware Co., LLC's authorized representatives. ### **TERMS**

For all approved open account customers, terms are NET 30 from date of invoice. All invoices are past due thereafter. Additionally, the Customer shall be responsible for all collection costs, court costs and reasonable attorney's fees (where allowed by law) in connection with the recovery of any delinquent amount.

### **FREIGHT**

All orders are shipped FOB Stamford, Connecticut using Accurate Lock and Hardware Co., LLC's carrier of choice following customer's requirements (ground, next day air, second day air, 3-day). All shipments are sent PREPAID and added to the invoice. If a customer provides their own freight account number for the freight charges, Accurate Lock and Hardware Co., LLC will apply a handling fee per box. This handling fee varies based on service selected, please contact us for details.



## DELIVERY

Scheduled shipping dates are based on estimated manufacturing lead times providing that all required information has been provided by the customer and the customer account remains in good standing. We reserve the right to withhold shipment of orders on past due accounts.

Accurate will use reasonable efforts to ship products by the estimated ship date but makes no guarantees as to delivery dates. Under no circumstances shall Accurate be liable or accountable for consequential damages due to failure of delivery.

## CLAIMS

In the event of Company or Customer error, claims for shortages, pricing errors and/or incorrectly filled orders must be submitted within thirty (30) days from receipt of material.

## INVOICE DEDUCTION

No invoice deductions are accepted. Please contact Accurate Lock and Hardware Co., LLC immediately if you feel there has been a pricing error and/or an order has been incorrectly filled upon receipt of an order confirmation.

## CHANGES/CANCELLATION OF ORDERS

Our products are custom manufactured to order; therefore, all purchase orders are non-cancelable upon commencing of work and all shipped goods are non-returnable. When changes are required while order is still in production, Accurate Lock may charge costs for material and labor expenses that have been incurred prior to notification from Customer and acknowledgement by an Accurate Lock and Hardware Co, LLC representative.

## RETURNS

It is the policy of Accurate Lock and Hardware Co., LLC to not accept returns of any materials.

Return of product due to customer order error or accommodation must be pre-arranged with Accurate Lock and Hardware Co., LLC and approved in writing by Sales Management.

All products returned must meet the following criteria to be considered a return eligible for credit:

- Shipped and invoiced within the previous one hundred twenty (120) days.
- A MINIMUM restocking fee of 45% will be charged.

Upon receipt and verification by Accurate Lock and Hardware Co., LLC that the returned merchandise is satisfactory, a credit will be issued for the billed product amount less the MINIMUM 45% restocking fee. No credit on freight.

Return of product that appears defective must be discussed with an Accurate Lock and Hardware Co., LLC Sales Representative who will give the appropriate instructions based on the particular case. Credits can only be used against open orders/invoices. Credits will not be redeemed for cash. Credits must be used for purchases within 1 year of the date of issue.
